LOGGING AND LUMBERING EXCLUSION

This policy does not apply to any **DAMAGES** for the following:

- 1. logging or lumbering operations by or for the **INSURED**;
- 2. **PROPERTY DAMAGE** to timberlands of others;
- 3. fire fighting expenses.
